Corona virus emerged from the city of Wuhan, China on December 31, 2019. Corona virus belongs to a family of enveloped, single stranded RNA viruses called *Coronaviridae*. Wuhan experienced an outbreak of the disease at the end of December, 2019 which killed more than eighteen hundred people and infected over seventy thousand individuals within fifty days of the epidemic. The symptoms of the virus include; cough, shortness of breath, diarrhea, fever and loss of smell, and the incubation period of the virus range from 1-14 days, most commonly around five days.

According to current evidence, COVID-19 virus is primarily transmitted between people through respiratory droplets and contact routes. Droplet transmission occur when a person is in close contact with a person who has respiratory symptoms e.g., coughing and sneezing. Transmission can also occur by direct contact with infected individuals and indirect contact with surfaces in the immediate environment or objects used on the infected individual.
