Corona Virus also known as COVID 19, emerged in Wuhan, China on December 31, 2019. It belongs to the Coronaviridae family in the Nidovirales order. An emerging business hub of China, at the end of 2019 experienced an outbreak of the disease corona virus that killed more than eighteen hundred and infected over seven thousand individuals within the fifty days of epidemic. Symptoms are seen within five days or it ranges from two to fourteen days. The symptoms are, diarrhoea, cough, shortness of breath, fever and loss of smell. When an infected person is in close contact with a non-infected person the virus is easily spread. When infected people sneezes the virus remains in the air for a while and non-infected people could contact it especially through crowded places. Currently there is no vaccine but we are advised to prevent it by washing ones hands regularly, maintaining physical distance from others, use of masks among others.

CORONA VIRUS IN NIGERIA

Corona Virus cases has been increasing drastically in the past few months since February 27, 2020. It has taken more than a hundred thousands of lives, making COVID 19 spread like wild fire, especially from foreign returnees and international travelers. Government have put in effort through the Nigerian Center for Disease Control (NCDC) to curb the spread of the deadly virus. NCDC (NIGERIAN CENTER FOR DISEASE CONTROL):

It is the government agency with the mandate to coordinate the surveillance

detection and response to infectious disease control outbreak. Over the past years, NCDC has deployed a new tool for disease surveillance. The surveillance, outbreak response management and analysis system (SORMAS) is a system jointly developed between NCDC and HZI (Helmholtz centre for infection). NCDC is located in Osun, Lagos, Oyo, Abuja, Sokoto, Kaduna, Kano, Ebonyi, Borno, Plateau, Rivers.
