- 1. Explain with the aid of analogies ten features of a good cyberpreneur.
- A good cyberpreneur must be self-confident.

So, say I'm starting up a service in an industry that's already competitive, for example an ecommerce service like jumia and konga. I have to be confident that I am making the right decision in starting up this business and handle situations with inferiority and any other type of complex.

• A good cyberpreneur must be multi-skilled.

As a cyberpreneur, I must possess multiple skills such as communication skills, technical skills as well as possess leadership skills and be a jack of trade. I need communication skills to be able to communicate with investors, my staff and other brands.

• A good cyberpreneur must be willing to take risks.

As the owner of an online platform I should be willing to take risks because you never know until you try. For example, I should seize the opportunity of partner up with an international brand by hosting them on my website or app and thereby that thrusts my business to an international fore front.
- Create an idea as an entrepreneur and how do you want to implement it based on cyber to take advantage of this Corona virus holiday.

## Answer

As a cyberpreneur, I want to create a service call "we cater". This service is for buying goods (for example food, provisions and medications) for people who are at home during this pandemic. This will be a website that will allow Nigerian citizens to order whatever they need and give specifications and then our staff will have it delivered to their doorsteps. In order to maintain customer health and protection against the virus, the delivery man will have no physical contact with the customer as well as be wearing gloves and masks. The website will also have a feature in which customers could view the covid-19 numbers just to keep them informed on the situation. The website makes money through online advertisers as well as the customer paying a fee. We would also be hosting restaurants and supermarkets on the website in order to give them an online platform and they would pay 20% of earnings to us and would be charged with the responsibility of delivering the food or products to the customer. In order to stand out, we will be providing an employment feature on the website for other people by allowing people in need of money to register as the people who will buy the products for the customers and deliver these products to the customer's doorstep while wearing protective wear (which would be provided by us giving them money to get these items). The person keeps 55% of the fee paid by the customer while we keep 45%.

Things to take into considerations

- That there are other people who have such business (jumia one), so we need to stand out. We do this by also providing employment for citizens in need of money and displaying the covid 19 statistics.
- Advertisement: in order to make people aware of our online platform we will need advertise. We plan on doing this by paying google to advertise us on YouTube and their various platforms, also on Instagram and other social media platforms to get awareness.

• Finances: I would need to gather financial resources to create the website, pay for advertisements and paying the online staff. This would be from personal savings, friends and family because official investors may be hard to find because of the state of the economy. To create the website, we will use the platform www.squarespace.com which will cost roughly around \$20 and other web features costing \$15. The cost of advertisement on instagram will be around N3,000.
