A pressure group is a formal or organised body with a common interest whose fundamental aim is to

Put pressure on any governmental institution with the goal of influencing government policies and laws

To its own advantage. It is referred to as "The Functional Representative" because of the idea that they

Represent different sectors of the society based on their functions. They aim at protecting the interest of

Their members or groups which could be educational, religious, social and business-like such as Nigeria

Labour Congress (NLC) and they ensure that the government does their bidding.

Pressure Groups and political parties may appear similar but are very different from each other. The

Differences are that:

a. Political parties seek to gain government powers while pressure groups do not seek to gain power,

Rather their aim is to influence political decisions.

b.	Political parties have a wide range of policies while pressure groups narrow their goals.
c.	Political parties do account for their actions while pressure groups are not actually accountable for
Their actions.	
d.	Political parties are formally organized than pressure groups However, they relate together to achieve
Certain social changes.

Arise when the democratic process becomes dominated by a few specific groups by them focusing public

• E. They ensure that the interests of the minority groups are not trampled upon by the government.

• F. They are instrumentals in the mounting of pressure on government so that they can implement

Policies that are to the benefit of citizens.

- The pressure groups may adopt various strategies to achieve their goals including lobbying elected
- Officials, media advocacy, and direct political action. The degree to which such groups are able to
- Achieve their goals may depend on their ability to be recognized as legimate by the population, media,
- And by those in power. They lobby with government officials directly or might sometimes lobby these
- Government officials through friends, spouses, children and other relatives.
