## THEMES

Demola's desire for keziah's love shapes his act of sexual coercion towards her. Keziah stuck to her core values but she let her guard down and decided to give Demola a chance to be friends not knowing the devilish scheme he and his companions had cooked up. Demola loved Keziah so much he was blinded to logic and influenced to make poor decisions.
- 2. **JUSTICE**: Our primary social adjustment is a denial of justice. Good morning Sodom shows an example of proper enactment of justice as a human duty.
